**The form overleaf has been designed for Councillor members of the LGPS to name a beneficiary or beneficiaries to receive the lump sum death grant payable in the event of their death.**

Should you die before the pension has come into payment then the death grant is equal to your retirement lump sum. Should your death occur within the first five years of receiving your pension and you were under age 75 at the date of your death, then the death grant payable will be five times your annual pension reduced by the pension already paid to you up to your date of death.

**Please ensure that you read the notes below before completing the form.**

- It is possible to name any number of individuals or incorporated or unincorporated organisations to receive the death grant.
- When completing the *Expression of Wish* form, please make sure that the percentage share column is completed for each individual beneficiary (even if you are naming only one) and that the sum of the percentage shares equals 100%.
- If you want to name more than five beneficiaries, please provide their details on a separate signed sheet of paper and attach it to this form.
- The London Borough of Hammersmith and Fulham (LBHF) retains absolute discretion to decide whom any death grant is paid to. Having this discretion means the potential liability for the assessment of inheritance tax on the value of the grant will be avoided. The LBHF will of course have the greatest regard to your wishes in respect of the payment of the grant.
- Naming your beneficiary / ies will usually allow the LBHF (as the Administering Authority) to pay the death grant quickly and without the need to wait for your estate to be settled and Probate obtained.
- If LBHF has been unable to pay the grant within two years of the date of your death, the grant will form part of your estate and payment will be made to your personal representatives. Payment of a death grant after two years will result in the death grant being taxed.

You can change your named beneficiaries at any time by completing another expression of wish form, which can be obtained from Pension Services.
